General terms & Conditions for Groups

All Groups bookings are subject to the following Terms and Conditions

1. APPLICATION

All bookings must be done by writing to the CEI- Centre d'Echanges Internationaux by email.

The sending organisation is required to provide CEI with a list of participants including last and first names, gender, date of birth, as well as any information about the participants' health condition, allergies, and special diets at least one month before the beginning of the stay.

Inscriptions will be processed only if accompanied with a deposit and a signature of the general terms and conditions

2. PRICES

Prices include all services listed in provided quotation.

3. PAYMENT CONDITIONS

Bookings are processed on receiving 30% of the non-refundable total amount.

The payment of the balance invoice must be received no later than 30 days before the first day of the programme.

All bank charges have to be settled by the sending organisation. The invoice will thus be increased if expenses were not anticipated from his part.

4. CONFIRMATION

On receiving the complete booking form and deposit, CEI will provide the sending organisation with a confirmation and invoice indicating the remaining balance.

All the necessary information regarding the stay will be sent to the agent at the latest 1 week prior to arrival, providing full payment has been received.

Every modification or additional services/request for any aspect of the program need to be noticed at least 3 weeks in advance. After this delay, the modification may be refused or the CEI may apply a modification fee (in addition to the fee directly generated by the modification)

5. INSURANCE

CEI is covered by a public and legal liability to third parties' insurance.

It is the sending organisation's responsibility to ensure that all participants have the relevant travel and medical insurance including personal liability, accident and repatriation coverage.

Participants from EU countries must bring their European Insurance card.

Participants are not insured by CEI for stolen goods or loss of personal belongings.

6. VISA

It is the sending organisation's responsibility to contact the French Embassy or Consulate in their home country to enter French territory; verifying application procedures and requirements and making the necessary appointments. CEI will provide the supporting documentation.

Visa refusal and cancellation

If a visa is refused, cancellation fees will apply as stated below. Refunds may be made at the discretion of CEI after having received written evidence of refusal 30 days before the starting date of the programme.

7. CANCELLATION:

Cancellations must be confirmed by writing to CEI by mail, email or fax.

▪ By the sending organisation

Cancellation of the entire group

- 60+ days before starting date receives the non-refundable deposit of 30%
- Between 59 days to 45 days before starting date receives 50% of the total invoice
- Between 44 days to 30 days before starting date receives 75% of the total invoice
- 29 days before starting date and for no show receives 100% of the total invoice

Cancellation of participants in the group

- In the event of a group decreasing in size by 10% or more after the programme rate is set and agreed by both sides, CEI may alter the price according to the number of cancellations, informing the sending organisation by email.

While every effort is made to limit the costs incurred by cancellations, the following scale of charges will be applied to participants withdrawing from a group.

- 45 days and more before starting date receives the administration fee of 300€ per participant
- Between 44 days to 30 days before starting date receives 75% of the total invoice
- 29 days before starting date and for no show receives 100% of the total invoice

In the event of a group increasing in size after the price has been set and agreed, CEI will accept new bookings on availability. CEI may alter the given price accordingly and the sending organization will be informed.

8. BEHAVIOUR:

CEI reserves the right to expel a participant and ask for an immediate home return in case of unacceptable behaviour (theft, alcohol or drug abuse, incorrect conduct...)

In case of an anticipated return for personal or discipline reasons, no refund will be made.

9. NON-SOLICITATION AGREEMENT:

The sending organisation agrees not to contact directly with the hotels, bus companies, local guides...provided by CEI during a 2-year period but to book through CEI.

10. GDPR AND IMAGE RIGHTS:

In compliance with new GDPR rules on the processing of personal data, CEI ensures that the rights of data subjects are respected.
