The U.S. Department of Education implemented regulations that nursing programs (PN, RN and APRN) must adhere to if they participate in Title IV HEA funding. Nursing programs need to provide:

- A list of all states/jurisdictions where the institution's curriculum meets state educational requirements for licensure or certification*
- A list of all states/jurisdictions where the institution's curriculum does not meet state educational requirements for licensure or certification
